Deadline: Friday, February 17, 2012

This prestigious competition is designed to recognize the contributions of teams of architects, contractors and developers in creating and implementing outstanding building projects in Los Angeles.

SUBMISSION

Please submit your outstanding building projects for consideration at www.labusinesscouncil.org by 5:00 p.m. on Friday, February 17, 2012.

ELIGIBILITY

Projects must be located within the County of Los Angeles and completed during the last two calendar years, 2010 / 2011.

Exceptions: Projects under construction as of 12/31/2011 may be submitted in the "Under Construction" category; projects not yet under construction as of 12/31/2011 may be submitted in the "Design Concept" category.

JUDGING CRITERIA

Winning projects are selected based on their contribution to the Los Angeles landscape. Criteria include, but are not limited to, aesthetic design value, use of materials and contribution to the fabric of the neighborhood / community. Awards are presented to the project team – composed of the architect, contractor and owner/developer. The jury reserves the right to consider projects for additional categories.

RULES

Submissions include an online entry form that includes a project description, up to four images and a non-refundable entry fee of \$125 (due/paid in full upon receipt of submission in order to be included for jury review.)

NOTIFICATION

Winners will be notified of their award on or before Friday, March 30, 2012 and officially recognized in the media and at the luncheon on Wednesday, June 20, 2012. At least two members of the submitting team must be present in order to receive the award.
